

The set of statistics presents performance of Polish farms providing their data to Farm Accountancy Data Network (FADN). The variables and economic margins used are fully consistent with FADN Standard Results published annually by DG AGRI of the European Commission (EC).


The liaison agency responsible for FADN in Poland i.e. organisation of data collection, data processing, data transfer to EC is IAFE-NRI.

Basic information:



- The FADN field of observation covers only commercial holdings, producing at least 90% of Standard Output (SO) value generated by all the farms in a given country. Minimal economic size allowing the farm to be included in the FADN field of observation in Poland equals to 4 000 euro SO.
- Polish FADN farms sample is representative according to three grouping criteria: economic size, type of farming and FADN region. More than 11 thousand farms deliver data for the Polish FADN survey.
- Common Typology of Agricultural Holdings is a classification of farms by economic size and type of farming in FADN regions. Type of farming is determined by the share of SO value coming from particular farm activities in the total value of farm SO. Economic size constitutes a sum of SO values coming from all farm activities expressed in euro.

Structure of farms by types





Standard Results by type of production representative for the Polish FADN field of observation (average per farm)







for the Polish FADN field of observation (average per farm)**






Family Farm Income per family working unit^N in relation and average net salary in national economy [—]

From 2020, the data from the selection plan developed in 2018 and the SO "2013" coefficients are used to weigh the results of the sample into the field of observation. The change in the structure of farms observed in Poland (which is visible in the selection plan) therefore also causes a change in the structure of farms in the presented standard results of the Polish FADN.

Selected definitions:

^j Total output	SE131	PLN	Total output of crops and crop products, livestock and livestock products and of other output. Sales and use of (crop and livestock) products and livestock + change in stock of products + change in valuation of livestock – purchases of livestock + various non-exceptional products.
^k Total inputs	SE270	PLN	Total inputs are the sum of specific costs, overheads, depreciation and external factors. Costs linked to the agricultural activity of the holder and relating to the output of the accounting year. Included are amounts relating to inputs produced on the holding (farm use) = seeds and seedlings and feed for grazing livestock and granivores. When calculating FADN standard results, farm taxes and other dues are not included in the total for costs but are taken into account in the balance "Subsidies and taxes" on current and non-current operations.
^l Family Farm Income	SE420	PLN	Remuneration to fixed factors of production of the family i.e. work, land and capital (in case of legal entity farms only land and capital) and remuneration to the entrepreneur's risks (loss/profit) in the accounting year. It equals to FNVA – total external factors (i.e. wages, rent and interest paid) + balance subsidies and taxes on investments.
^m Unpaid labour input	SE015	PLN	Refers generally to family labour expressed in Family Work Units (FWU = Family AWU).
ⁿ Family Farm Income / FWU	SE430	PLN/FWU	FFI expressed per family work unit (FWU = Family AWU) was calculated only for farms where inputs of family work occurred (SE015>0). [SE420/SE015]
